**AMENDED AND RESTATED ARTICLES OF ORGANIZATION**

**OF**

THESE AMENDED AND RESTATED ARTICLES OF ORGANIZATION (the "**Amended and Restated Articles**") of PUPPYLOVE LLC, a Florida limited liability company (the "**Company**"), are submitted in accordance with Section 605.0202 of the Florida Revised Limited Liability Company Act (the "**Act**") for purposes of amending and restating the Articles of Organization of the Company in their entirety. From and after the date of filing hereof, the Amended and Restated Articles of the Company shall be as set forth in paragraph SECOND below.

**FIRST:** The information required by Section 605.0202 of the Act is as follows:

- (i) The present name of the limited liability company is "PUPPYLOVE LLC."
- (ii) The date of filing of the Articles of Organization of the Company was July 10, 2015.
- (iii) These Amended and Restated Articles will take effect at the time and date on which they are accepted for filing by the Florida Department of State.
- (iv) These Amended and Restated Articles have been duly executed and are being filed in accordance with Section 605.0202 of the Act.

**SECOND:** The Amended and Restated Articles of the Company are as follows:

**ARTICLE I**  
**NAME**

The Managers shall have the powers, duties and authority set forth in the Act, subject to any express limitations contained in the Operating Agreement. **ARTICLE VI**  
**RESTRICTIONS ON TRANSFER;**  
**ADMISSION OF ADDITIONAL OR SUBSTITUTE MEMBERS**

Among other things, the Operating Agreement restricts the sale, transfer, pledge, hypothecation, exchange, assignment or other disposition by any means, including but not limited to those which are voluntary, involuntary, by operation of law, by the laws of descent and distribution, or otherwise (each, a "**Transfer**") of the membership interests in the Company. Any such Transfer shall be void *ab initio* unless made in strict compliance with the terms and conditions of the Operating Agreement. In addition, no person or entity shall be admitted as a member of the Company or issued any membership interest in the Company,

The Company is created pursuant to Chapter 605, Florida Statutes, and shall be governed by the laws of the State of Florida.
