The undersigned person, acting as an authorized representative of CLC 1, LLC, under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, adopts the following Articles of Organization:

**ARTICLE I - NAME**


ARTICLE VII - MANAGEMENT BY MANAGER
