FIRST: The Articles of Organization were filed on July 14, 2015, and assigned Florida document number L15000120527.

SECOND: The following Amended and Restated Articles of Organization of BIGHAM ENTERPRISES, LLC. were adopted by the limited liability company. These Amended and Restated Articles of Organization hereby amend and restate (in their entirety) the Articles of Organization, to read as follows:

Limitation on Agency Authority of Members

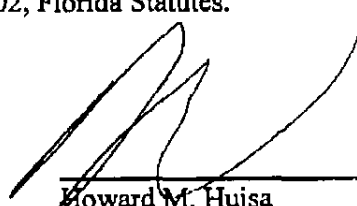
