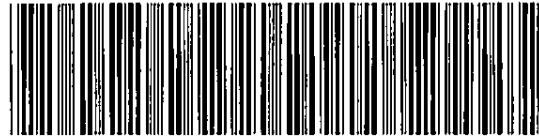


ARTICLES OF DISSOLUTION


1. The name of the Company is Advanced Medical Solutions Group, LLC, a Florida limited liability company.

IN WITNESS WHEREOF, these Articles of Dissolution have been executed on the 15th day of December, 2017.


