**ARTICLES OF ORGANIZATION
OF
TWELVE ENTERPRISES, LLC**

The undersigned person, under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, adopts the following Articles of Organization:

ARTICLE I - NAME

The name of this limited liability company is:


