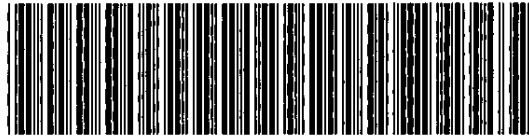

SECOND: The following amendment to the Articles of Organization was adopted by the limited liability company by the action of all of its members on September 23, 2015:


Article IV of the Articles of Organization is hereby deleted in its entirety and is replaced by the following new Article IV:
