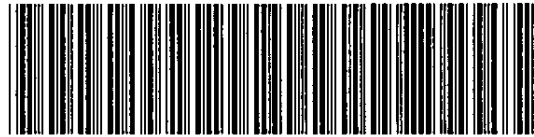

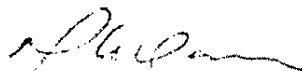
ARTICLE VI - INITIAL MEMBER
