ARTICLES OF ORGANIZATION for KOKOMO HOLDINGS, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be Kokomo Holdings, LLC ("Company").

ARTICLE IX - ADMISSION OF NEW MEMBERS



The existence of the Company shall commence at 12:01 A.M. on July 24, 2015.


