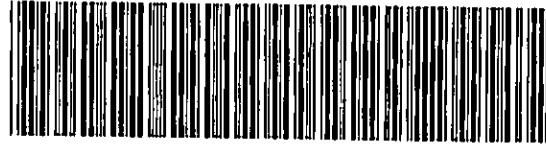


1. The name of the limited liability company is TB HOMES LAND XIV LLC.
