**ARTICLE I**

**Name, Mailing Address and Purpose of Organization**

The name of this limited liability company is Mezrah Asset Holdings, LLC (the "Company"). The Company's principal address and mailing address is 5350 W. Kennedy Blvd., Tampa, Florida 33609. **Indemnification**




**CERTIFICATE DESIGNATING**
