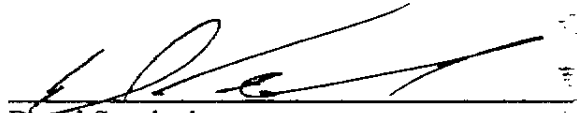

I, David Spurlock, the undersigned, being of legal age, do of my own personal knowledge make the following statements and declare them to be true.

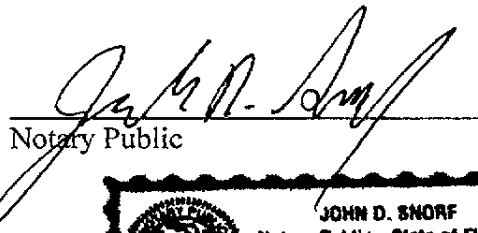
