AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF
PALMER ATRIUM, LLC

The undersigned, acting as organizer of **PALMER ATRIUM, LLC**, under the Florida Revised Limited Liability Company Act ("the Act"), adopts the following Articles of Organization for said limited liability company:

ARTICLE I
NAME

The name of the limited liability company shall be **PALMER ATRIUM, LLC** ("the LLC").

ARTICLE II
PERIOD OF DURATION

The period of duration shall commence upon the filing of these Articles with the Department of State, and shall be perpetual thereon, unless the LLC is sooner dissolved as provided by these Articles of Organization.

ARTICLE III
PURPOSE

The LLC is organized pursuant to the Florida Revised Limited Liability Company Act to conduct any lawful business, subject to any provisions of law governing or regulating such business within Florida, including the authority to hold, purchase, mortgage, lease and convey real and personal property in Florida. The LLC shall have the powers described in the Florida Revised Limited Liability Company Act and as set forth in the LLC's Operating Agreement. Each Manager shall have these powers.
