AMENDED AND RESTATED ARTICLES OF ORGANIZATION
OF
VIRSUM, LLC

Pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act, the undersigned, being a member of Virsum, LLC (hereinafter the "Company"), a Florida limited liability company, does hereby certify:

FIRST: The Articles of Organization of the Corporation were originally filed with the Secretary of State of Florida on July 28, 2015, document number 15000128982.

SECOND: These Amended and Restated Articles of Organization, which supersede the original Articles of Organization and all amendments to them, were adopted by the members of the Company on December 18, 2015. To effect the foregoing, the text of the Articles of Organization is hereby restated and amended as herein set forth in full:

ARTICLE I –Name
