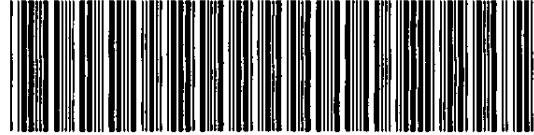

ARTICLES OF ORGANIZATION
OF
Dean & Kerestes, PLLC

A Florida Professional Limited Liability Company

The undersigned, for the purpose of forming a professional limited liability company under Chapters 605 and 621 of the Florida Statutes, does hereby make, acknowledge, and file the following Articles of Organization.

Article I. Name

The name of this professional limited liability company (the "Company") is:

Dean & Kerestes, PLLC

Article II. Term of Existence

The existence of the Company shall begin on July 21, 2015 and shall continue perpetually unless terminated, liquidated, or dissolved sooner according to the terms of the Company's operating agreement (the "**Operating Agreement**") or applicable law.

Article III. Principal & Mailing Address

The mailing and street address of the principal office of the Corporation is 1060 Woodcock Rd., Orlando, FL 32803.

Article IV. Business Purpose and Powers

The sole and specific purpose of the Company's operations shall be the practice of law, and the Company shall have all the powers granted a professional limited liability company under the laws of the State of Florida, in accordance with Chapters 605 and 621 of the Florida Statutes; provided, however, nothing herein shall be interpreted to limit the Company from investing its funds in real estate, mortgages, stocks, bonds, or any other type of investments, or from owning real or personal property necessary for the rendering of such professional service.

Article VI. Registered Office and Registered Agent

Article VII. Board of Managers

The Company is to be managed by one or more managers, and is therefore a manager-managed company. The initial board of managers shall consist of two (2) managers. This number may be increased or decreased from time to time in accordance with the Company's Operating Agreement, but shall never be less than one (1).
