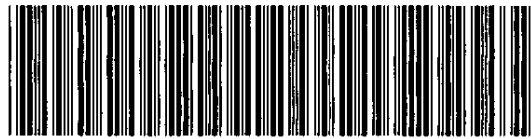

The undersigned, Daniel P. Churukian, as a member of D & S Mattress, LLC hereby presents these Articles of Organization as the Articles of Organization of D & S Mattress, LLC, a limited liability company formed under the provisions of Chapter 608, Florida Statutes.

ARTICLE I – NAME

The name of the limited liability company is:

D & S Mattress, LLC

This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II – PRINCIPAL OFFICE ADDRESS

The initial mailing and street address of the principal office of the Company is 10956 Country Ostrich Drive, Pensacola, FL 32534.

ARTICLE III – PURPOSES AND POWERS

This Company is organized for the purpose of selling mattresses and bedding accessories.

The Company may exercise all powers and rights which a limited liability company may exercise under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, as such chapter exists and may hereafter be amended.
