**ARTICLES OF ORGANIZATION
OF
ANDERSON EYE CARE LLC**

The undersigned, for the purpose of forming a limited liability company under the Revised Limited Liability Company Act, Chapter 605, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be ANDERSON EYE CARE LLC (the "Company").

ARTICLE II -- ADDRESS

The street address and mailing address of the Company is:

ARTICLE III -- DURATION

ARTICLE VI -- LIMITATION ON AGENCY AUTHORITY OF MEMBERS

ARTICLE VII -- WRITTEN OPERATING AGREEMENT

Any operating agreement entered into by the members of the Company, and any amendments or restatements thereof, shall be in writing. No oral agreement among any of the members or managers of
