

#### ARTICLES OF ORGANIZATION

<u>OF</u>

#### PERSISTENCE, LLC



The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 605, hereby make, acknowledge, and file the following Articles of Organization.

#### **ARTICLE I - NAME**

The name of the limited liability company shall be PERSISTENCE, LLC. The street address of the principal office of the limited liability company in Florida shall be 1907 S. Alexander Street, Ste. 2, Plant City, Florida 33566, and the mailing address shall be 1907 S. Alexander Street, Ste. 2, Plant City, Florida 33566.

#### **ARTICLE II - DURATION**

The limited liability company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State.

#### ARTICLE III - PURPOSES AND POWERS

The specific purpose for which this limited liability company is organized is to buy, sell, lease and manage real estate. The general purpose for which the limited liability company is organized is to buy, sell, trade, lease, and to enter into any and all types of agreements related to or pertaining to real or personal property, and to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. #### <u>ARTICLE V - CAPITAL CONTRIBUTIONS</u>

#### ARTICLE VI - ADDITIONAL CAPITAL CONTRIBUTIONS

Each member shall make additional capital contributions to the limited liability company only upon the unanimous consent of all the members.

The limited liability company shall be dissolved as may be provided in the Operating Agreement of the limited liability company, but only upon unanimous consent of all members.

#### **ARTICLE IX - MANAGEMENT**


