The undersigned hereby submits these Articles of Organization (these "*Articles of Organization*") for purposes of forming **Weeks Real Estate, LLC**, a Florida limited liability company, under the Florida Revised Limited Liability Company Act, Chapter 605, *Florida Statutes*.

ARTICLE I – Name:

The name of the limited liability company formed pursuant to the filing of these Articles of Organization is Weeks Real Estate, LLC, a Florida limited liability company (the "*Company*").

ARTICLE II – Address:


