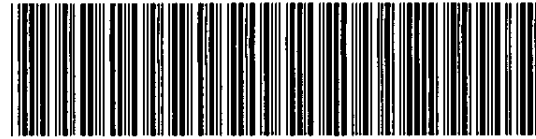

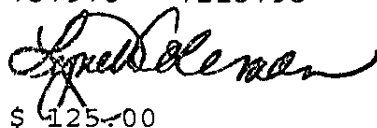

**ARTICLE V - PURPOSE**

This company is organized for the following purposes: to purchase, or lease, invest in, or otherwise acquire and own real and personal property, or any interest therein, of every kind, or character; to lease real estate for offices, apartments and other facilities and accommodations for rental to the public and for other commercial purposes; to buy and sell, assign, transfer, trade and deal in goods, wares, merchandise, real and personal property, and services, of every class, kind, and description; to sell, or lease, or mortgage, or otherwise dispose of any real or personal property it owns, or any interest therein; to borrow money and mortgage, or pledge its assets; to enter into, make, perform, and carry out contracts of every kind, for any lawful purpose, and **in general, to engage in and transact any and all lawful businesses for which a limited liability company may be organized under the laws of the State of Florida**, except that it shall not conduct a banking, safe deposit, trust, surety, express, railroad, canal, telegraph, telephone or cemetery company, a building and loan association, fraternal benefit society, state fair or exposition, or any occupation that requires a professional license for which members are not licensed to practice.

**ARTICLE VI - DURATION**

The company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State and shall continue to exist until the company is dissolved as provided in these Articles of Organization, or as provided in the company's Operating Agreement.

**ARTICLE VII - ADDITIONAL CAPITAL CONTRIBUTIONS**

Each member shall make additional capital contributions to the company only on the unanimous consent of all the members or as provided in the regulations.

**ARTICLE VIII - MEMBERS AND THE ADMISSION OF NEW MEMBERS**

**DANIEL T. KULACH, and TYSON B. DUANE.** shall be the initial Members, and except as set forth in the regulations, no additional members shall be admitted to the company except with the unanimous written consent of all the members of the company and on such terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the company as set forth in the regulations of the company, but the transferee shall have no right to participate in the management of the business and affairs of the company or become a member unless all the members of the company other than the member proposing to dispose of his or her interest approve of the proposed transfer by written consent.

**ARTICLE IX - MEMBERS RIGHT TO CONTINUE BUSINESS**

The company shall be dissolved on the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminated the continued membership of a member in the company, unless the business of the company is continued by unanimous approval of all the remaining members.

The company shall be managed by Managers, or by a Manager, in accordance with the Operating Agreement, or the resolutions adopted by the members for the management of the business and affairs of the company, The Operating Agreement, or the resolutions of the members may contain any provisions for the conduct, regulation and management of the affairs of the company not

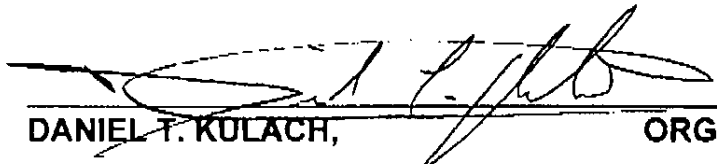
**ARTICLE XI - AMENDMENTS**

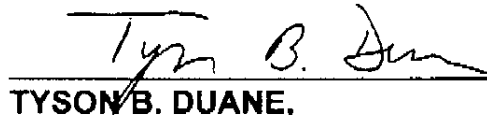
These Articles of Organization may be amended by the members in the manner provided by law.

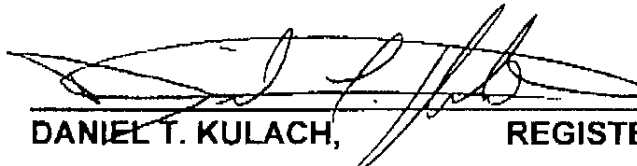
