ARTICLES OF ORGANIZATION

OF

LANE GATE CAPITAL LLC A Florida Limited Liability Company

In accordance with the Florida Revised Limited Liability Company Act as set forth in Chapter 605 of the Florida Statutes, the undersigned Manager does hereby adopt the following Articles of Organization for LANE GATE CAPITAL LLC (the "Company"):

ARTICLE I

NAME

The name of the Company is LANE GATE CAPITAL LLC and its principal place of business shall be in the City of Delray Beach, County of Palm Beach, State of Florida, but it shall have the power and authority to establish branch offices at such place or places as may be designated by the members.

ARTICLE II

DURATION

The limited liability company shall exist until dissolved in a manner provided by law, or as provided in accordance with the regulations adopted by the Members.

ARTICLE III

ADDRESS

The mailing address and street address of the principal office of the Company is 2444 San Pietro Circle, Palm Beach Gardens, FL 33410.

ARTICLE IV

INITIAL REGISTERED OFFICE AND AGENT

The name and address of the initial registered agent of the Company is Cottie E. Rankin, 2444 San Pietro Circle, Palm Beach Gardens, FL 33410.

ARTICLE V

MANAGEMENT

The Company is to be managed by one or more managers and is, therefore, a manager - managed company.

ARTICLE VI

INDEMNIFICATION

To the fullest extent permitted by law, the Company shall indemnify any person who was or is a party to any proceeding by reason of the fact that he/she is or was a manager, managing member or officer of the Company or is or was serving at the request of the Company as a manager, managing member, director or officer of another limited liability company, corporation, partnership, joint venture, trust or other enterprise against liability incurred in a manner he/she reasonably believed to be in, or not opposed to, the best interests of the Company and, with respect to any criminal action or proceeding, had no reasonable cause to believe his/her conduct was unlawful. The Company shall reimburse each person for all costs and expenses, including, without limitation, attorneys' fees, reasonably incurred by hlm/her in connection with any such liability in the manner provided for by law or in accordance with the regulations of the Company. The rights accruing to any person under the foregoing provision shall not exclude any other right to which he/she may be lawfully entitled, nor shall anything therein contain or restrict the right of the Company to indemnify or reimburse such person in any proper case even though not specifically provided for herein.

The undersigned, being a Manager of the Company, hereby certifies that the foregoing constitutes the proposed Articles of Organization of LANE GATE CAPITAL LLC.

In accordance with Section 605.0203(1)(b), Florida Statutes, the execution of this document constitutes an affirmation under the penalties of perjury that the facts stated herein are true. The undersigned is aware that any false information submitted in a document to the Department of State constitutes a third degree felony as provided for in Section 817.155, Florida Statutes.
