ARTICLE I - NAME

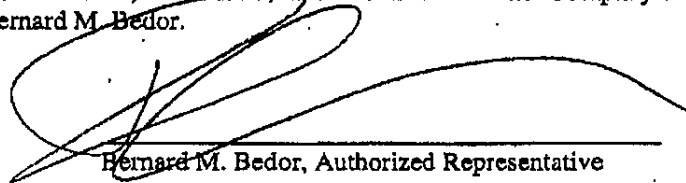
The name of the Limited Liability Company shall be SPINAL RESOURCES IP HOLDINGS, LLC (the "Company").
