The undersigned companies, in accordance with the Florida Revised Limited Liability Company Act, hereby adopt the following Articles of Merger:

ARTICLE I: PARTIES

LCI has agreed to pay any members of any limited liability company with appraisal rights, the amount to which such members are entitled under the provisions of ss. 605.1006 and 605.1061 - 605.1072.
