The undersigned authorized representative of a member of the captioned Limited Liability Company, under the provisions of the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, adopts the following Articles of Organization:

ARTICLE I

Name, Mailing Address and Purpose of Organization

The name of this limited liability company is WIG Columbus, LLC (the "Company"). The Company's principal address and mailing address is 204 37<sup>th</sup> Avenue North, Ste 311, St. Petersburg, Florida 33704. The Company's initial registered agent is David M. 




