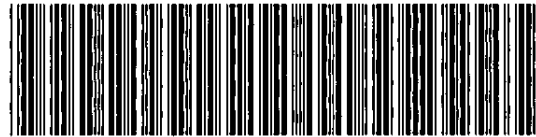

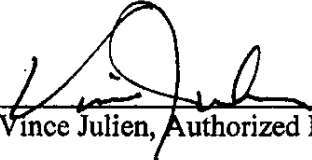

ARTICLE I
NAME

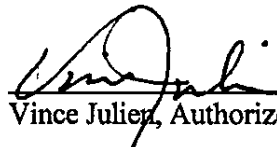
**ARTICLE VII

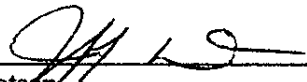
