Pursuant to the provisions of Chapter 605 of the Florida Statutes (the "Florida Revised Limited Liability Company Act"), the undersigned representative of the members, for the purposes of forming a Florida limited liability company, hereby adopts the following Articles of Organization:

ARTICLE 1 NAME

The name of the company is NEW LIFE PARADISE, LLC (the "Company").

ARTICLE 2 DURATION AND PLACE OF BUSINESS

The period of duration of the Company is perpetual and its principal place of business is at 8930 Watercrest Circle West, Parkland, FL 33076. The management of the Company is vested in the Managers, as defined in the 6.1. Company's Operating Agreement.
