

ARTICLES OF ORGANIZATION

OF

MINKSLIDE HOLDING, LLC, A Florida Limited Liability Company

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 605, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I. NAME

The name of the limited liability company shall be **MINKSLIDE HOLDING, LLC**.

ARTICLE II. ADDRESS

The mailing address and street address of the principal office of the company shall be:

ARTICLE IIII. DURATION

ARTICLE VI. ADDITIONAL CAPITAL CONTRIBUTIONS

Each member shall make additional capital contributions to the company only on the unanimous consent of all the members.
