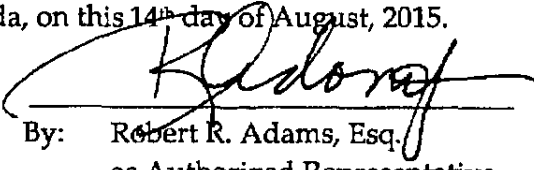
ARTICLE IX – TERMINATION OF EXISTENCE

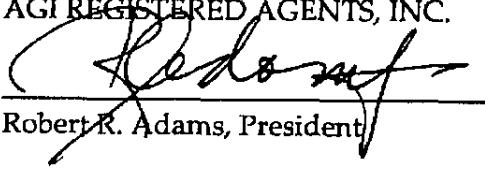
