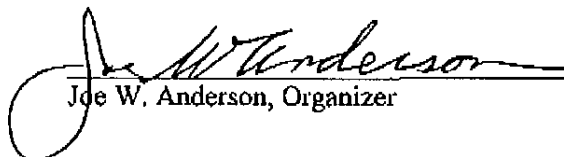
**ARTICLE III**
