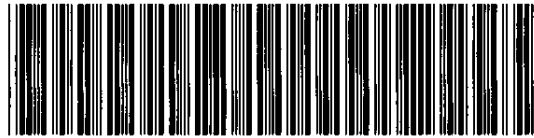

ARTICLES OF ORGANIZATION
OF

The undersigned, for the purpose of forming a limited liability company under the Revised Florida Limited Liability Company Act, Chapter 605, Florida Statutes, hereby makes, acknowledges and files these Articles of Organization.

ARTICLE I - NAME

ARTICLE VI - ADDITIONAL CAPITAL CONTRIBUTIONS


Each member shall make additional capital contributions to the Company as set forth in the Operating Agreement.


