ARTICLE III – Registered Agent and Office

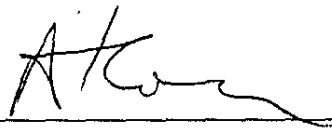

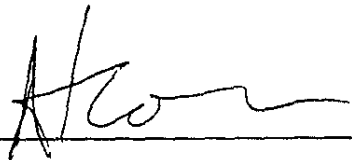
