**ARTICLES OF ORGANIZATION  
OF  
TASH COMMERCIAL, LLC**

The undersigned, A. Preston Hood and Ann O. Hood, natural persons competent to contract and the members of Tash Commercial, LLC, file these Articles of Organization of Tash Commercial, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

**ARTICLE I - NAME**

The name of the limited liability company is Tash Commercial, LLC, which is referred to in these Articles of Organization as the "Company."

**ARTICLE II - PRINCIPAL OFFICE ADDRESS**

The mailing and street address of the Company is 271 E. Miracle Strip Pkwy., Mary Esther, FL 32569. The Company's principal office may hereafter be at such other place or places as its member or members from time to time may determine.

**ARTICLE III - PURPOSE AND POWERS**

The Company is organized for any legal and lawful purpose for which a limited liability company may be organized and shall have all powers and rights which a limited liability company may exercise pursuant to Chapter 605, *Florida Statutes*.

**ARTICLE IV - COMMENCEMENT AND TERM OF EXISTENCE**

**ARTICLE V - REGISTERED OFFICE AND AGENT**

**ARTICLE VI - MANAGEMENT**

The Company shall be managed by a manager or managers in accordance with the terms of the Operating Agreement of the Company. 


