ARTICLES OF ORGANIZATION

FOR

A FLORIDA LIMITED LIABILITY COMPANY

The undersigned, acting as the organizer of 2549 GRASSY POINT, LLC, under the Florida Revised Limited Liability Company Act, Chapter 605, Fla. Stat., adopts the following Articles of Organization:

ARTICLE I

NAME

The name of the limited liability company is:

ARTICLE II

INITIAL PRINCIPAL OFFICE ADDRESS,
