## ARTICLES OF CORRECTION TO ARTICLES OF ORGANIZATION OF ARTOS, LLC

Pursuant to the provisions of Section 605.0209, Florida Revised Limited Liability Company Act (the "Act"), the undersigned limited liability company makes the following correction to its Articles of Organization ("Articles"):

- 1. The name of the limited liability company is ARTOS, LLC (the "Company").
- 2. The Company's Articles were filed on August 27, Document # L15000144378.
- 3. Article IV of the Articles is deleted in its entirety and exprected follows:

## "ARTICLE IV Management
