**ARTICLES OF ORGANIZATION  
OF  
STRIPEY 26EW DEVELOPMENTS LLC**

The undersigned, being a duly authorized representative of the Member(s), desiring to form a limited liability company under and pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes (the "Act"), does hereby adopt the following Articles of Organization:

**ARTICLE I. NAME**

The name of the limited liability company is STRIPEY 26EW DEVELOPMENTS LLC (the "Company").

**ARTICLE II. ADDRESS**

The mailing address and street address of the principal office of the Company are 2800 Biscayne Boulevard, Suite 310, Miami, Florida 33137.

**ARTICLE III. REGISTERED AGENT AND OFFICE**

The Company designates 2800 Biscayne Boulevard, Suite 310, Miami, Florida 33137 as the street address of the initial registered office of the Company and names Mariana Goldemberg as the Company's initial registered agent at that address to accept service of process within this state.


