- (3) To restate its articles of organization, a limited liability company must deliver to the department for filing an instrument, entitled "Restatement of Articles of Organization," which contains the following: The present name of the company. (a)
- (b) The date of the filing of its articles of organization.
- (c) All of the provisions of its articles of organization in effect, as restated.
- The delayed effective date, as provided under s. 605.0207, if the restatement is not effective on the date the department files (d) the restatement.
