ARTICLE VI - MANAGEMENT

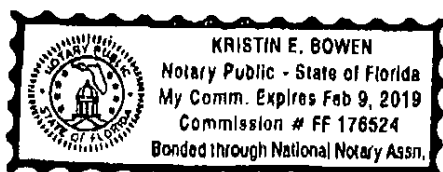




