ARTICLE I
NAME

The name of this Limited Liability Company shall be NOBLE SUNNY, LLC, the Company).

NEW MEMBERS**

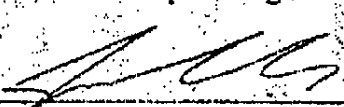

The Company shall be terminated and dissolved upon:

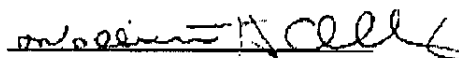
- (A) the vote of all members holding an interest in the Company;
