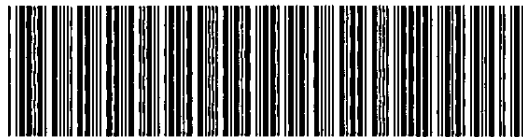

**ARTICLES OF ORGANIZATION
OF
DESIGNER'S RESOURCE CENTER OF FLORIDA, LLC
A FLORIDA LIMITED LIABILITY COMPANY**

**ARTICLE I
NAME**

The name of this Limited Liability Company shall be **DESIGNER'S RESOURCE CENTER OF FLORIDA, LLC** ("Company"), and its principal place of business and mailing address shall be located at 2000 Alden Road, Suite B, Orlando, Florida 32803.

**ARTICLE II
COMMENCEMENT OF EXISTENCE**

This Company shall exist for a period of thirty (30) years commencing on the date of filing of these Articles of Organization with the Florida Secretary of State, unless sooner dissolved according to law.

**ARTICLE III
GENERAL PURPOSE; GENERAL POWERS**

The general purpose of this Company shall be the transaction of any and all lawful business. This Company shall have all of the powers enumerated in the Florida Limited Liability Company Act, as the same now exists and as hereafter amended, and all such other powers as are permitted by applicable law.

**ARTICLE IV
CONTRIBUTIONS TO CAPITAL**

The initial capital of the Company shall be Five Hundred and No/100 Dollars (\$500.00), which shall be contributed by the members in accordance with their initial ownership interests in the Company, which are as follows:

No Member shall be entitled to receive interest in its, his or her contributions to capital. Each Member's contribution to capital shall be in cash or property as agreed upon by the Members. Additional contributions to capital by the Members may be required pursuant to acts of the Board of Managers.

ARTICLE V **INITIAL REGISTERED OFFICE AND AGENT**

The initial registered office of this Company shall be located at 2000 Alden Road, Suite B, Orlando, Florida 32803, and the initial Registered Agent of this Company at that address shall be Opal Jean Karcewski. The Company may change its Registered Agent or the location of its registered office, or both, from time to time without amendment of these Articles of Organization.

ARTICLE VI **MANAGER - MANAGED INITIAL MANAGER(S)**

The management or conduct of the business and affairs of the Company shall be vested in a Manager as provided in the Operating Agreement of the Company. This Company shall have one (1) Manager initially. The number of Manager(s) may be either increased or diminished from time to time by the Operating Agreement of the Company. The name and street addresses of the initial Manager of this Company, who shall serve as Manager until the first annual meeting of the Members or until their successors are elected and qualify, is:

The power to adopt, alter, amend or repeal the Operating Agreement of the Company shall be vested in the Manager.

ARTICLES VIII
ADMISSION OF NEW MEMBERS

Additional Members may be admitted from time to time on such terms and conditions as determined by a majority in interest of the Members.

ARTICLE IX
DEATH, RETIREMENT, RESIGNATION, BANKRUPTCY, EXPULSION
OR DISSOLUTION OF MEMBER

In the event of the death, retirement, resignation, bankruptcy, expulsion or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a member in the Company, the remaining Members shall continue the business of the Company pursuant to the applicable provisions of law, these Articles of Organization and the Operating Agreement.

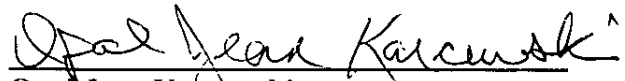
ARTICLE X
