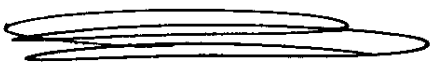

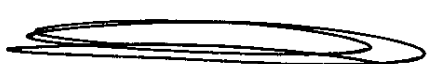
1. The name of the Corporation immediately prior to the filing of these Articles of Conversion is Miranda Contracting, Inc.

ARTICLE III - INITIAL REGISTERED AGENT AND ADDRESS

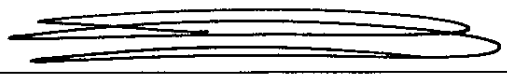

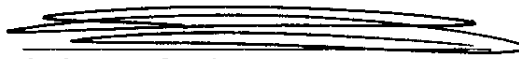
**CERTIFICATE OF DESIGNATION
