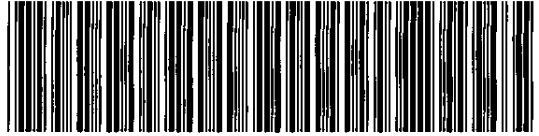

RIGHT OF CONTINUANCE




