**ARTICLES OF ORGANIZATION
OF

**ARTICLE I
NAME**

The name of this limited liability company is Amwat 1157, LLC, a Florida limited liability company (the "Company").

**ARTICLE II
DURATION**

The undersigned executed these Articles of Organization effective as of the 3rd day of September, 2015.




