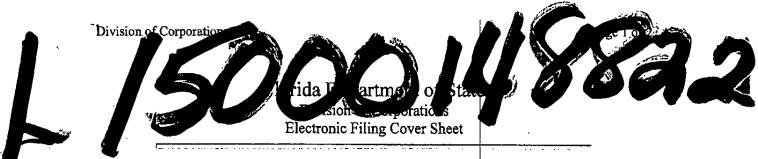

### ARTICLES OF ORGANIZATION OF CRM SOLUTIONS LLC
