The mailing address and the street address of the principal office of the Limited Liability Company is 6740 SE 110th Street, #508, Belleview, Florida 34420.

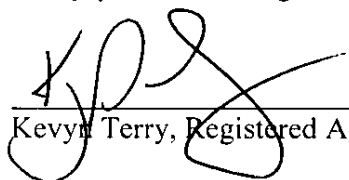
ARTICLE III – REGISTERED OFFICE AND REGISTERED AGENT

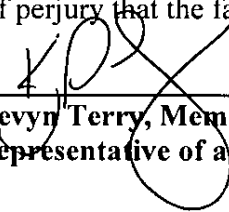
