FIRST: The date of filing of the articles of organization was September 2, 2015.

SECOND: The following amendment(s) to the articles of organization was/were adopted by the limited liability company:

A) Article IV shall hereby be amended to state that the Managing Members of the company shall be:

THIRD: The following is a new article to be included in the Articles of Organization:

A) ARTICLE V. PURPOSE AND POWERS

In addition to the powers authorized by the laws of the State of Florida for limited liability companies, the general nature of the business or businesses to be transacted, and which the limited liability company is authorized to transact, shall be as follows:

B) ARTICLE VI. CAPITAL CONTRIBUTIONS

Capital contributions in the amount of \$1,000.00 cash shall be paid to the limited liability company by the members in the following amounts: COSMOVISION HOLDING LLC (100%): \$1,000.00. Additional contributions
