**ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF
COPS & ROBBERS HOLDINGS, LLC**

WHEREAS, the name of the company is COPS & ROBBERS HOLDINGS, LLC, a Florida limited liability company ("Company"); and

WHEREAS, the Company was formed pursuant to the laws of the State of Florida effective August 28, 2015 and assigned document number L15000151099; and

WHEREAS, the Manager of the Company has recommended the amendments to the Articles of Organization set forth below and the sole Member has approved such amendments on March 11, 2016; and

WHEREAS, the undersigned Company, by and through its Manager and pursuant to the provisions of Section 605 of the Florida Statutes, amends the aforesaid Articles of Organization in the manner hereinafter set forth to be effective upon the filing of these Articles of Amendment with the Secretary of State;

NOW, THEREFORE, the undersigned hereby amends the Articles as follows:

1. Article I of the Articles is hereby modified as follows:

**ARTICLE I
NAME**

The name of the limited liability company is:

AECM, LLC

2. The Company shall be managed by a manager as provided in the Company's Operating Agreement. The manager shall be Cops & Robbers Management, LLC, a Tennessee limited liability company, and it shall serve as such until replaced according to the provisions of the Company's Operating Agreement.

3. Except as modified herein, the Articles of Organization of said Company shall be and remain in full force and effect.
