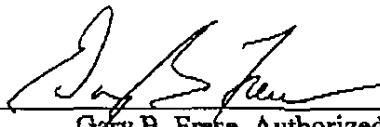
ARTICLE IX - ADOPTION OF OPERATING AGREEMENT
