Dear Mrs. Brown,

I just got off the phone with Mrs. Geena McCloud. (I hope I have her name spelled correctly). I was advised to send this to you via facsimile, and that you would be able to complete the filing.

Some three years ago, my client had an erroneous filing as a Corporation that should have been a LLC. I attempted to correct this by filing Articles of Organization couple of weeks ago. My intent was to dissolve the INC once the LLC was formed. However, you sent me a letter (attached) stating that the LLC's name was too close to another entity's name. When I pulled up the entity by the document number of the name conflict you gave me, it is that of the INC we need to dissolve after establishing the LLC.

The document number of the LLC is W15000059649. The tracking number of the LLC is 300276707253.

The document number of the INC is P09000008503.

Again, please establish the LLC and then dissolve the INC. It should have never been filed as a Corporation, and the IRS contested the EIN that was issued. The client has never filed as a INC with the IRS. We were hired to straighten out the EIN issue and then get the client up to date with the IRS filings. Your help in this is very critical.
