Address

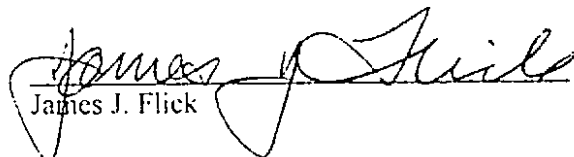

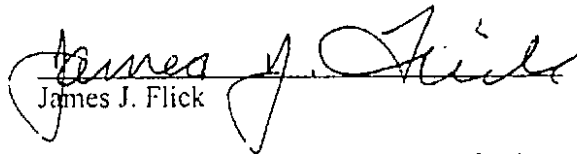
