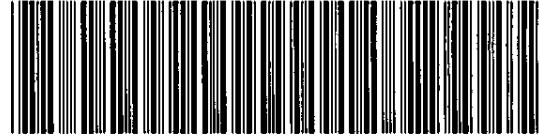

ARTICLES OF ORGANIZATION

OF

The undersigned hereby forms a limited liability company under Chapter 605 of the Laws of the State of Florida (the "Florida Revised Limited Liability Act" or the "Act").

ARTICLE I
NAME

The name of the limited liability company is Holy Cross Physician Partners ACO, LLC (the "Company").

The effective date of this filing is April 29, 2014.




