The undersigned, Adam Christiansen, a natural person competent to contract and a member of BeachFit30A, LLC, hereby presents these Articles of Organization as the Articles of Organization of BeachFit30A, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is BeachFit30A, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."
